### Situation actuelle

Depuis Novembre 2010, je suis Professeure de Sciences Economiques à l'[UFR SEGMI](#) (Sciences Économiques, Gestion, Mathématiques, Informatique) de l'[Université Paris Nanterre](#). J'y ai intégré le département d'Économie ainsi que l'unité de recherche, [EconomiX](#). De 2011 à 2014, j'ai été membre du bureau du département d'Économie et responsable de l'ensemble des Masters d'Économie. De 2012 à 2014, j'ai été directrice du département d'Économie. Depuis 2011, je suis la responsable de la Mention de Master [Économie Appliquée](#) et j'ai assumé également la direction d'un des axes de recherche au sein d'EconomiX, l'axe *Macroéconomie Internationale, Banque, et Econométrie Financière* jusqu'en 2019. A ce titre, j'ai fait partie du directoire et du conseil de laboratoire de mon unité de recherche, de 2011 à 2019. Depuis la rentrée universitaire 2021, j'assume la direction d'une des Ecoles doctorales de l'Université Paris Nanterre, l'école doctorale [Économie, Organisations, Société](#) qui regroupe les sciences économiques, les sciences de gestion, la sociologie, la démographie et l'histoire contemporaine.

### Enseignements
